SECOND AMENDMENT TO THE PROTECTIVE RESTRICTIONS, MISL COVENANTS, LIMITATIONS AND EASEMENTS FOR ABBEY PLACE VILLAS, SECTION ONE AND ABBEY PLACE VILLAS, SECTION TWO

Pursuant to the provisions of Article VII, Section 26 of the Protective Restrictions, Covenants, Limitations and Easements for Abbey Place Villas, Section One, as recorded in Plat Cabinet B, page 130 and Document Number 93-000622, and Article VII, Section 25 of the Protective Restrictions, Covenants, Limitations and Easements for Abbey Place Villas, Section Two, as recorded in Plat Cabinet C, page 139 and Document Number 960064968, in the Office of the Recorder of Allen County, Indiana, the undersigned, being the owners of more than 67% of the Lots in each section of said subdivision, are entitled to, and do hereby make the following amendment to said Protective Restrictions, Covenants, Limitations and Easements:

Article III, Section 4, B. a. of the Protective Restrictions for Abbey Place Villas, Sections One and Two is amended to read as follows:

a. for the maintenance of the common areas once they have been initially completed, which shall include but shall not be limited to fertilizing, mowing, and replanting when necessary of the grass, and including the care and maintenance of shrubs, trees, flowers or other plants; also and for mowing the grass and applying fertilizer and mulch on the yards of owners. Owners are responsible for the care of their yards other than listed above, including maintenance of shrubs, trees, flowers or other plants, including watering of their yards and plants.

Article III, Section 4, B. d. of the Protective Restrictions for Abbey Place Villas, Sections One and Two is amended to read as follows:

d. for the plowing or snow removal from the streets, driveways and sidewalks

Article III, Section 7. G. (a) of the Protective Restrictions for Abbey Place Villas, Sections One and Two is amended to read as follows:

(a) The Regular Assessment shall be no more than Fifty Dollars (\$50.00) per month on each Dwelling Unit commencing ninety (90) days after the Building Permit has been issued, prorated on a daily basis for a period of time less than a month.

The above amendment to Article III, Section 7. G. (a) is for the purpose of correcting a scrivener's error. The current assessment is Sixty Dollars (\$60.00) per month on each Dwelling Unit commencing ninety (90) days after the Building Permit has been issued, prorated on a daily basis for a period of time less than a month; however, that assessment is subject to change in accord with the Restrictions herein and the Bylaws of the Abbey Place Villas Community Association, Inc.

Article VII, Section 9 of the Protective Restrictions for Abbey Place Villas, Section One is amended to include the following clause, which clause is already in effect for Section Two:

No accessory structure of 144 square feet in area or larger may be built or located on any Lot unless the owner of the Lot has first obtained from the Allen County Zoning Administrator an Improvement Location Permit for the structure.

Article VII, Section 3 of the Protective Restrictions for Abbey Place Villas, Section Two is amended to read as follows:

Section 3. No Dwelling Unit shall be located on any Lot nearer to the street line than the minimum building set back lines shown on the recorded plat. No Dwelling Unit shall be located on any interior Lot nearer than 25 feet to the rear lot line with the exception of lots Numbered 88, 89, 90 and 91. No Dwelling Units on said Lots Numbered 88, 89, 90 and 91 shall be located on the interior Lot nearer than 20 feet to the rear lot line. No Dwelling Unit shall be located on any Lot nearer than 7 feet to an interior lot line; provided, however, that no side yard shall be required on the side of the Lot where one-family attached dwellings abut.

Article VII, of the Protective Restrictions for Abbey Place Villas, Section Two is amended to include the following as Section 11A.:

<u>Section 11A.</u> No boats, campers, trailers of any kind, busses, mobile homes, motor homes, trucks (other than non-commercial pickup trucks), motor cycles, mini bikes, mopeds, or any other vehicles of any description other than normal passenger automobiles, shall be permitted, parked or stored anywhere within the Properties; provided, however, that nothing herein shall prevent the parking or storage of such vehicles completely enclosed within a garage.

The purpose of this Amendment is to make the Protective Restrictions, Covenants, Limitations, and Easements for Abbey Place Villas, Sections One and Two conform to each other and facilitate the operation of Sections One and Two as a single, unified subdivision as was intended.
