## SECOND AMENDMENT

TO

THE DEDICATION, PROTECTIVE RESTRICTIONS, COVENANTS, LIMITATIONS, EASEMENTS AND APPROVALS APPENDED TO AND MADE A PART OF THE DEDICATION AND PLAT OF CHERRY HILL, SECTION XIV, d/b/a BROOKS POINTE VILLA ASSOCIATION, INC., A SUBDIVISION IN ABOITE ST. JOSEPH TOWNSHIP, ALLEN COUNTY, INDIANA

The undersigned, Cindy Snouffer, the presiding President of Brooks Pointe Villa Association, Inc., an Indiana Domestic Non-profit Corporation, with the consent of owners of more than seventy-five percent (75%) of the Lot Owners of Cherry Hill, Section XIV, located in Brooks Point Villas, a subdivision in St. Joseph Township, Allen County, Indiana, hereby amends the Declaration of Dedication, Protective Restrictions, Covenants, Limitations, Easements and Approvals, and amendments thereto, appended to and make a part of the Dedication and Plat of Cherry Hill, Section XIV, a subdivision in St. Joseph Township, Allen County, Indiana, as recorded in Plat Cabinet E, page 66, and as previously amended by an Amendment thereto dated February 16, 2009, and recorded as Document Number 2009006681 (the "Restrictions"), by amending the Restrictions and added the new following provision:

Article VII, Section 48 is hereby added and shall read:

Section 48. Rental or Leasing of any residential lot/property within Brooks Pointe is strictly prohibited. No Owner is permitted to lease or rent the property owned within Brooks Pointe Villa Association. Residential structures are meant to be solely for the use of the Owner and Owner's family. No short term or long term contractual agreement for others to use or occupy the residential dwelling is permitted.
