TWENTY-FIRST AMENDMENT TO DECLARATION OF HORIZONTAL PROPERTY OWNERSHIP FOR STILLWOOD CONDOMINIUMS HORIZONTAL PROPERTY REGIME

This Twenty-First Amendment to Declaration is made this <u>19</u> day of April, 1999 and executed by the undersigned as owners and mortgagees of the Units within Stillwood Condominium Horizontal Property Regime ("Stillwood Condominiums").

WHEREAS, by the Declaration of Horizontal Property Ownership Stillwood's Horizontal Property Regime as recorded in the office of the Recorder of Allen County, Indiana, on the 26th day of September, 1998, as Document No. 88-39530 ("Declaration"), certain real estate described therein was submitted to the Horizontal Property Act of the State of Indiana creating Stillwood Condominiums;

WHEREAS, the right to amend the Declaration is reserved to Stillwood Condominiums Association upon approval of not less than 75 percent of the Co-Owners (as defined in the Declaration);

WHEREAS, there have been 20 amendments to the Declaration to date including two amendments designated as the "Fifth Amendment", two amendments designated as the "Tenth Amendment", and no amendment designated as the "Seventeenth Amendment" with the most recent amendment designated as the "Nineteenth Amendment" dated August 8, 1996 and recorded on August 8, 1996 in the office of the Recorder of Allen County, Indiana, as Document No. 96-43981.

NOW, THEREFORE, Stillwood Condominium Association (the "Association"), upon approval of not less than 75 percent of the Co-Owners in a designated vote at a meeting duly held in accordance with the provisions of the Declaration and By-Laws, hereby amends the Declaration by deleting in its entirety the following provision of the Declaration:

13. <u>Private Streets</u>. The streets and entranceways shown on the Site Development Plan known as Stillwood Drive and Stillwood Court shall be private easements for the benefit of all Home Owners and their invitees.

The Declarant grants, dedicates and conveys to each Home Owner, their successors and assigns, their invitees and all public and quasi-public parties, including by way of illustration and not by way of limitation, fire, law enforcement, emergency, public utility, mail and delivery vehicles, a perpetual right and easement for the purpose of ingress to and egress from STILLWOOD CONDOMINIUMS. These easements may not be accepted by the Allen
