FIRST AMENDMENT TO THE DEDICATION AND DECLARATION OF PROTECTIVE RESTRICTIONS, COVENANTS, LIMITATIONS, EASEMENTS, AND APPROVALS APPENDED TO AS PART OF THE DEDICATION AND PLAT OF THE CLIFFS, A SUBDIVISION IN ABOITE TOWNSHIP, ALLEN COUNTY, INDIANA

This First Amendment to the Dedication and Declaration of Protective Restrictions, Covenants, Limitations, Easements, and Approvals Appended to as Part of the Dedication and Plat of The Cliffs, a Subdivision in Aboite Township, Allen County, Indiana (this "First Amendment") is entered into by and among **THE CLIFFS COMMUNITY ASSOCIATION**, **INC.** (the "Master Association") and the undersigned **OWNERS** (defined in the Restrictions) under the following circumstances:

- A. On October 31, 2003, Ternet Development, Inc. f/k/a Masterpiece Homes, Inc., as the Developer of the Cliffs (the "Developer"), executed the Dedication and Declaration of Protective Restrictions, Covenants, Limitations, Easements, and Approvals Appended to as Part of the Dedication and Plat of The Cliffs, a Subdivision in Aboite Township, Allen County, Indiana, as filed in the Office of the Recorder of Allen County, Indiana as **Document Number 203113550** (the "Restrictions").
- B. The Lots enumerated and encumbered by the Restrictions are all part of a subdivision commonly known as The Cliffs; there exists, as of December 31, 2012, only one class of Membership (Class A) of the Master Association pursuant to Article IV of the Restrictions; and all of the undersigned Owners represent Class A members of the Master Association.
- C. It being deemed by the Master Association and the undersigned to be in the best short and long-term interests of the Master Association and its membership, the Master Association, an Indiana non-profit corporation governing the affairs and business of The Cliffs, together with the requisite number of Owners, or more, needed to effectuate the same, desire to amend the Restrictions with this First Amendment.

NOW, THEREFORE, for and in consideration of the above and foregoing recitals, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Incorporation of Recitals; Defined Terms</u>. The above and foregoing recitals are incorporated into this First Amendment and made a part hereof as though originally set forth herein. All terms used herein with initial capital letters shall, unless otherwise defined herein, have the meaning ascribed to such terms in the Restrictions.
- 2. <u>Public Streets</u>. The Master Association is authorized hereby to make reasonable attempts to dedicate and otherwise convey all of the streets within the Subdivision to the Board of Commissioners of the County of Allen, Indiana pursuant to a separate Warranty Deed. The Board of Directors of the Master Association is authorized to take such action and execute such documentation as, if and when it believes is necessary and prudent in order to so dedicate and convey the streets in The Cliffs. The Developer, still an owner of several lots as of the date hereof, agrees to reasonably cooperate with the Master Association to the extent needed in order to effectuate the intentions of this First Amendment. If and only upon such dedication, all references in the Restrictions and the Plat to "private" nature of the streets are hereby deleted. In addition, Article VI, Section 47 is hereby deleted, except for subsection (j), which subsection shall be renamed as subsection "(a)") along with the following new subsection (b):
 - "(b) Subject to applicable laws and regulations of public and administrative agencies having jurisdiction thereover, and the obligations of utility companies and governmental bodies, the Master Association shall have the right and authority to make such arrangements and to perform such acts as may be necessary or desirable from time to time to keep the streets and Common Areas in the Subdivision; any Lots, areas, and blocks in the Subdivision owned by the Association or subject to its control and all structures and improvements thereon; and those facilities which affect the common good of the residents of the Subdivision, including without limitation sewer, water, gas, electric, street lighting, and telephone systems serving the Subdivision in good repair and condition and to make improvements thereof, including authority to contract for the cutting of grass, cleaning, beautifying, landscaping, and removal of trees, weeds, snow, ice, and debris from the streets and the areas, blocks, and lots of the Subdivision owned or under the jurisdiction of the Association in the maintenance, insurance, and repair of any structure, improvements or landscaping located thereon."
- 3. <u>Remaining Terms and Provisions.</u> Except as otherwise set forth above, the terms and provisions of the Restrictions remain unmodified and in full force and effect. In the event of any conflict or inconsistency between the terms and provisions of this First Amendment and the

terms and provisions of the Restrictions, the terms and provisions of this First Amendment shall in all instances govern and prevail.

IN WITNESS WHEREOF, this First Amendment has been executed by the Master Association, together with the undersigned Owners and members of the Master Association, all pursuant to the terms and provisions of the Restrictions. The effective date of this First Amendment shall be the date of its recordation with the Office of the Recorder of Allen County, Indiana.
