SECOND AMENDMENT TO THE DEDICATION AND DECLARATION OF PROTECTIVE RESTRICTIONS, COVENANTS, LIMITATIONS, EASEMENTS, AND APPROVALS APPENDED TO AS PART OF THE DEDICATION AND PLAT OF THE CLIFFS, A SUBDIVISION IN ABOITE TOWNSHIP, ALLEN COUNTY, INDIANA

This Second Amendment to the Dedication and Declaration of Protective Restrictions, Covenants, Limitations, Easements, and Approvals Appended to as Part of the Dedication and Plat of The Cliffs, a Subdivision in Aboite Township, Allen County, Indiana (this "Second Amendment") is entered into by and among **THE CLIFFS COMMUNITY ASSOCIATION, INC.** (the "Master Association") and the undersigned **OWNERS** (defined in the Restrictions) under the following circumstances:

- A. On October 31, 2003, Ternet Development, Inc. f/k/a Masterpiece Homes, Inc., as the Developer of the Cliffs (the "Developer"), executed the Dedication and Declaration of Protective Restrictions, Covenants, Limitations, Easements, and Approvals Appended to as Part of the Dedication and Plat of The Cliffs, a Subdivision in Aboite Township, Allen County, Indiana, as filed in the Office of the Recorder of Allen County, Indiana as **Document Number 203113550** (the "Restrictions"), as amended by that certain First Amendment to the Dedication and Declaration of Protective Restrictions, Covenants, Limitations, Easements, and Approvals Appended to as Part of the Dedication and Plat of The Cliffs, a Subdivision in Aboite Township, Allen County, Indiana, as filed in the Office of the Recorder of Allen County, Indiana as **Document Number** 2015031612.
- B. The Lots enumerated and encumbered by the Restrictions are all part of a subdivision commonly known as The Cliffs; there exists, as of December 31, 2012, only one class of Membership (Class A) of the Master Association pursuant to Article IV of the Restrictions; and all of the undersigned Owners represent Class A members of the Master Association.

- C. It being deemed by the Master Association and the undersigned to be in the best short and long-term interests of the Master Association and its membership, the Master Association, an Indiana non-profit corporation governing the affairs and business of The Cliffs, together with the requisite number of Owners, or more, needed to effectuate the same, desire to amend the Restrictions with this Second Amendment.
- **NOW, THEREFORE**, for and in consideration of the above and foregoing recitals, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:
- 1. <u>Incorporation of Recitals; Defined Terms</u>. The above and foregoing recitals are incorporated into this Second Amendment and made a part hereof as though originally set forth herein. All terms used herein with initial capital letters shall, unless otherwise defined herein, have the meaning ascribed to such terms in the Restrictions.
- 2. <u>Architectural Control Committee</u>. Article I, Section 1 and the last paragraph of Article III of the Restrictions are hereby deleted in their entirety, and the following shall be added as Article I, Section 1:
 - Section 1. "Architectural Control Committee" shall mean the body designated herein to review plans and to grant or withhold certain approvals in connection with improvements and developments to a Dwelling Unit or Lot. The Committee shall be composed of five (5) members. Until the Developer no longer owns any Lots within the Subdivision, the Developer shall appoint four (4) members of the Committee, provided, that at all times at least two (2) of the Committee members designated by the Developer must reside in The Cliffs. The fifth Committee member shall be appointed by the Master Association. The designation (or confirmation) of all five (5) Committee members shall be made at or promptly after each annual meeting of the Master Association. All decisions and actions of the Committee pursuant to these Restrictions shall be made by the affirmative vote of a majority of such members, provided that all members shall be provided full information about and opportunity to vote on all matters decided by the Committee (although any Committee member may designate another Committee member or a third party as its proxy for any such vote). The Master Association shall be apprised of all decisions or actions by the Committee. If the Developer fails to (or chooses not to) designate a member as provided herein for a Committee vacancy, such unfilled position shall become a designee of the Master Association. After the last Lot has been conveyed by the Developer to an Owner, the Committee shall be designated by the Master Association, and may thereafter, at the option of the Master Association, consist of three (3) members.

- 3. <u>Mailboxes</u>. Article VI, Section 30 is hereby amended such that all references therein to the "**Developer**" shall be replaced with the "**Master Association**".
- 4. <u>Remaining Terms and Provisions.</u> Except as otherwise set forth above, the terms and provisions of the Restrictions remain unmodified and in full force and effect. In the event of any conflict or inconsistency between the terms and provisions of this Second Amendment and the terms and provisions of the Restrictions, the terms and provisions of this Second Amendment shall in all instances govern and prevail.

IN WITNESS WHEREOF, this Second Amendment has been executed by the Master Association, together with the undersigned Owners and members of the Master Association, all pursuant to the terms and provisions of the Restrictions. The effective date of this Second Amendment shall be the date of its recordation with the Office of the Recorder of Allen County, Indiana.


